Role of Apex Committee


- Monitor the creation and adoption of the Healthy Streets policy

Role of the Department

- Conduct capacity building workshops
- Hold stakeholder discussions
- Communicate the benefits

Steps towards the **institutional setup**



Steps needed to be completed for **Stage 1 submission**

1. Update the Concept Note

In the BACKGROUND SECTION;

- 1. Update your city name at all locations where [CITY NAME] is highlighted

A. BACKGROUND




