





#### Step 1: Go through the submission checklist

#### Submission deliverables for 31st July

- **1. 3 presentations\*** (Max 15 slides each)
- 2. Photos\* (Maximum 20)
- 3. Additional documents (Maximum 5)
- 4. **Project Description\*** (2 questions)
- 5. Cover letter\*
- \* Submission Mandatory.



- Use your **official city email ID** while submitting your entry
- Google forms cannot be saved midway. We strongly recommend you to keep all the submission deliverables ready, including the project description text.
- All images and other files should be named with the format
   CITY NAME\_DELIVERABLE (Example - Malgudi\_photo 1)
- Ensure that all the information submitted is within the scope of the Streets4People Challenge
