Introduction

Water and energy are essential needs in day to day life. At the same time, these are most important inputs for any effort for social upliftment and economic growth of the country.

With the increasing demand by the growing population and improvement in economic status, the demands on the available resources are increasing and we have to constantly strive towards stretching the same water to satisfy larger needs. As a result, there is an urgency to conserve and utilize the limited availability of water resources in an optimum and efficient manner.

As a community resource, water needs to be managed and deployed in an equitable manner by involving all the stakeholders. While as individual stakeholders, manage their demands and supplies, the efforts will have to be collaborative and consensual.

Ministry of Water Resources, RD&GR is to organize the **India Water Week 2017** between **October 10-14, 2017** to use it as a platform to elicit ideas and opinions from global level decision makers, politicians, researchers and entrepreneurs in the field of water resources for mutual benefit and goodwill.



What is India Water Week

Conceptualized and organized for the first time in 2012, the India Water Week is an annual forum where the Ministry of Water Resources, RD&GR, Government of India discusses, talks, strategizes with eminent stakeholders through seminars, exhibitions and sessions to build public awareness, to get support to implement key strategies for conservation, preservation and optimum use of available water. This is the fifth event of its kind with the theme "**Water and Energy for Inclusive Growth**" focusing on improving role of water use across all sectors. The fourth event namely, India Water Week 2016 was organized with the theme Water for all: Striving together with Israel as partner country. The Conference was attended by more than 1500 national and international delegates and an exhibition covering an area of 3000 sqm as well as number of specialized add-on events as other highlights of the event.

PARTNERS IN ORGANISATION

The India Water Week (IWW) 2017 will be organized by the Ministry of Water Resources, RD & GR in co-ordination with nodal ministries of Agriculture; Environment, Forest and Climate Change; Rural Development; Urban Development; Drinking Water Supply and Sanitation; Power; New and Renewable Energy; Niti Aayog along with their associated expert organizations and Public Sector Units, key International Bodies and private and public business houses.



India Water Week (IWW) 2017 is going to be held from October 10-14, 2017 at Vigyan Bhawan, New Delhi with the theme "**Water and Energy for Inclusive Growth**"

What to Expect at IWW 2017

The IWW 2017 will be celebrated with a multi disciplinary conference and a concurrently running exhibition enriching the theme and showcasing the technologies and solutions available for the areas under deliberation of the meet. The event will have the following major components.

CONFERENCE

A multi-disciplinary dialogue in the form of a conference discussing issues of "**Water and Energy for Inclusive Growth**"

- **WATER, FOOD AND ENERGY SECURITY – ESSENTIAL REQUIREMENT FOR SUSTAINABLE DEVELOPMENT.**
- **WATER FOR INCLUSIVE GROWTH**
- **SUSTAINABLE ENERGY DEVELOPMENT – KEY FOR ALL ROUND ECONOMIC GROWTH.**
- **WATER AND SOCIETY.**

A large group of international and national persons of eminence are being invited for sharing their experiences in the field of Water and Power Management, Technical and Sociological interventions for achieving water and energy

security in their individual areas and manage the assets created on a participatory basis. In addition, there will be Special Sessions involving dignitaries, delegates, politicians, experts from the fields related to the event. Expert professional bodies and think tanks are invited to put up Side Events addressing specific issues under the theme.

At present, The online registration for the conference is free for all. However, the participation will be subject to the clearance of dues prior to the conference.

EXHIBITION

There will also be an exhibition running in parallel supporting the theme and showcasing the technologies, latest developments and solutions available for the areas in water and energy. The Government of India proposed to complete 99 prioritised Major & Medium Irrigation-AIBP projects in 18 States along with their CAD works by December 2019 under Pradhan Mantri Krishi Sinchayee Yojna (PMKSY) Mission established in

MoWR, RD & GR, The Mission will

- **Realize full irrigation potential and ensure completion of projects as per target**
- **Improve water use efficiency (Both Ground and Surface Water)**
- **Promote participatory Irrigation Management and formation of Water User Associates and NGOs**

For this the Government of India proposed a dedicated Long Term Irrigation Fund (LTIF) in NABARD with an initial corpus of Rs. 20,000 Crore for funding and fast tracking the implementation of projects under PMKSY. The final outlay including Central and State share is of the order of Rs. 77,908 Crore.

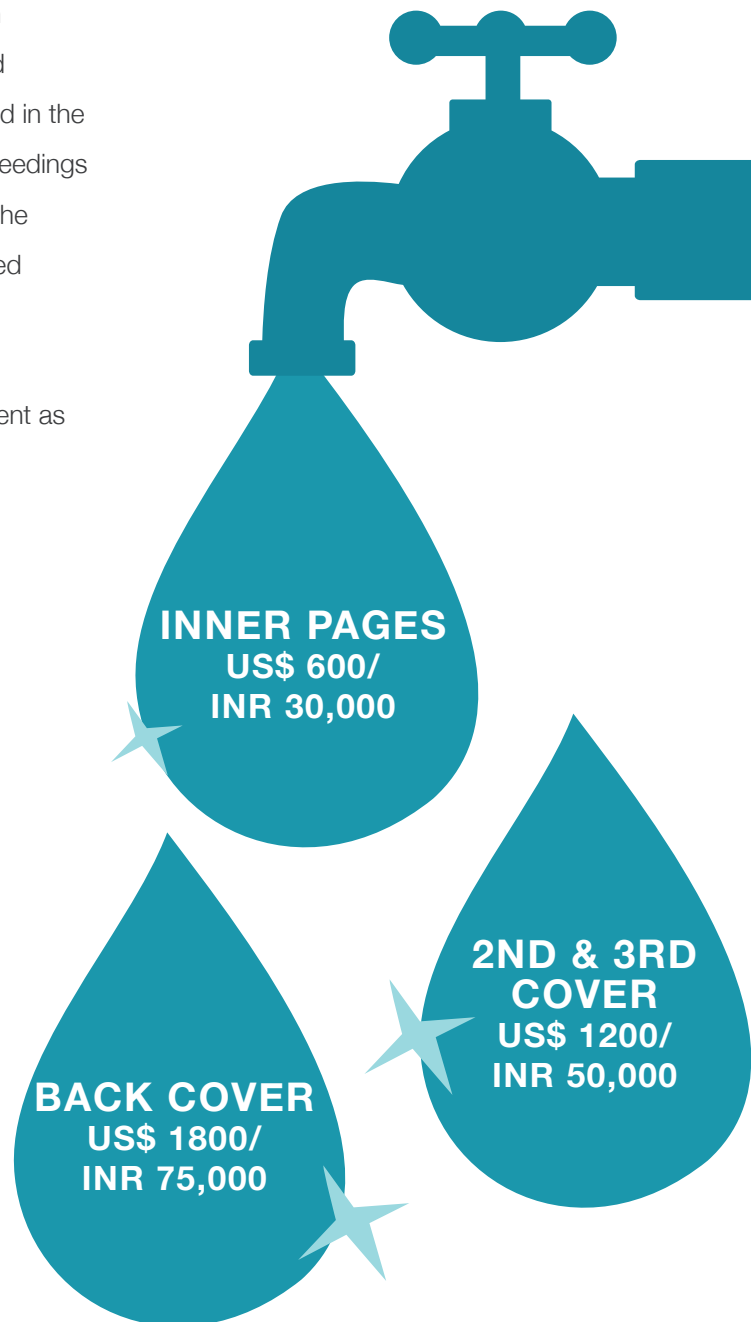
