#### Section 2: Instructions to Consultants

### Part I

#### Standard

#### 1. **Definitions**

- (a) *Client/Employer*means the Agency who has invited the bids for consultancy services and/ or with which the selected Consultant signs the Contract for the Services and to which the selected consultant shall provide services as per the terms and conditions and TOR of the contract.
- (b) *"Consultant"* means any entity or person or associations of person who have been requested to submit their proposals that may provide or provides the Services to the Client/Employer under the Contract.
- (c) *"Contract"* means the Contract signed by the Parties and all the attached documents listed in its Clause 1, that is the General Conditions (GC), the project Specific Conditions (SC), and the Appendices.
- (d) *"Project specific information"* means such part of the Instructions to Consultants used to reflect specific project and assignment conditions.
- (e) *"Day"* means calendar day.
- (f) *"Government"* means the government of India
- (g) *"Instructions to Consultants"* (Section 2 of the RFP) means the document which provides Consultants with all information needed to prepare their proposals.
- (h) *"LOI"* (Section 1 of the RFP) means the Letter of Invitation being sent by the Client/Employer to the consultants.
- (i) *"Personnel"* means professionals and support staff provided by the Consultant or by any Sub-Consultant and assigned to perform the Services or any part thereof;
- (j) *"Proposal"* means the Technical Proposal and the Financial Proposal.
- (k) *"RFP"* means the Request for Proposal prepared by the Client/Employer for the selection of Consultants, based on the SRFP.
- (1) *"SRFP"* means the Standard Request for Proposals, which must be used by the Client/Employer as a guide for the preparation of the RFP.
- (n) *"Assignment / job"* means the work to be performed by the Consultant pursuant to the Contract.
- (o) *"Sub-Consultant"* means any person or entity with whom, the Consultant subcontracts any part of the Assignment/job subject to the clause 5 of this RFP relating to conflict of interest.

(p) *"Terms of Reference"* (TOR) means the document included in the RFP as Section 5 which explains the objectives, scope of work, activities, tasks to be performed, respective responsibilities of the Client/Employer and the Consultant, and expected results and deliverables of the Assignment/job.

#### 2. Introduction

- 2.1 The Client/Employer named in the Part II Data Sheet will select consulting firm/organization (*the Consultant*) meeting basic eligibility criteria as mentioned in *Part II Data Sheet* and in accordance with the method of selection specified in the *Part II Data Sheet*.
- 2.2 The name of the assignment/Job has been mentioned in Part II Data Sheet. Detailed scope of the assignment/ job has been described in the *Terms of Reference in Section 5*.
- 2.3 The date, time and address for submission of the proposals have been given in Part II Data Sheet.
- 2.4 The Consultants are invited to submit their Proposal, for consulting Assignment/job named in the *Part II Data Sheet*. The Proposal will be the basis for contract negotiations and ultimately for a signed Contract with the selected Consultant.
- 2.5 Consultants should familiarize themselves with Local conditions and take them into account in preparing their Proposals. To obtain first-hand information on the Assignment/job and Local conditions, Consultants are encouraged to meet the Client/Employer's representative named in *Part II Data Sheet* before submitting a proposal and to attend a *Pre-Bid Meeting* if one is specified in the *Part II Data Sheet*. Attending the pre-bid meeting is optional. Consultant is advised to visit and examine the site and its surrounding and obtain for itself and on its own responsibility all information that may be necessary for preparing the proposal. The cost of visiting the site shall be at the consultant's own expenses
- 2.6 The Client/Employer will provide at no cost to the Consultants the inputs and facilities specified in the *Part II Data Sheet*, assist the consultants in obtaining licenses and permits needed to carry out the Assignment/job, and make available relevant project data and reports.
- 2.7 Consultants shall bear all costs associated with the preparation and submission of their proposals and contract negotiation. The Client/Employer is not bound to accept any proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Consultants.

#### 3. Eligibility of Association of Consultants and Sub-Consultants

3.1. If the consultant has formed an association of consultants, each member of the association of consultant shall be evaluated as per the qualification/ eligibility criteria set forth in Part II

data Sheet. The combined score of the each member of the association of consultant shall be taken into account for evaluation purpose. If any member of the association of consultants is dropped at the RFP stage, such an association of consultant is liable to be rejected by the Client/Employer. However, the Client/Employer, at its sole discretion, may decide to evaluate for short-listing such association of consultant without considering the strength of the dropped member and if found eligible, may allow such association of consultant to submit their proposal.

3.2. A consultant may associate with consultants and /or individual expert at the time of submission of proposal with. Under such circumstances each member of the association of consultant shall be evaluated as per the qualification/ eligibility criteria set forth in Part II data Sheet. The combined score of the each member of the association of consultant shall be taken into account for evaluation purpose. However, the Client/Employer shall deal with only the lead member for the purpose of this assignment. Although the contract shall be signed by all the members of the associations of the consultants, the lead member of the association of the consultant shall be responsible and liable to the Client/Employer for every aspects of their proposal, contract etc.

#### 4. Clarification and Amendment of RFP Documents

- 4.1 Consultants may request a clarification on any clause of the RFP documents up to the number of days indicated in the *Part II Data Sheet* before the proposal submission date. Any request for clarification must be sent in writing, or by standard electronic means to the Client/Employer's address indicated in the *Part II Data Sheet*. The Client/Employer will respond in writing, or by standard electronic means and will send written copies of the response (including an explanation of the query but without identifying the source of inquiry) to all Consultants. Should the Client/Employer deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure under para. 4.2 Below.
- 4.2 At any time before the submission of Proposals, the Client/Employer may amend the RFP by issuing an addendum in writing or by standard electronic means. The addendum shall be sent / uploaded on the websites for all Consultants and will be binding on them. To give Consultants reasonable time in which to take an amendment into account in their Proposals the Client/Employer may, if the amendment is substantial, extend the deadline for the submission of Proposals.

#### 5. Conflict of Interest

5.1 Client/Employer requires that Consultants provide professional, objective, and impartial advice and at all times hold the Client/Employer's interests paramount, strictly avoid conflicts with other Assignment/jobs or their own corporate interests and act without any consideration for future work.

- 5.2 Without limitation on the generality of the foregoing, Consultants, and any of their affiliates, shall be considered to have a conflict of interest and shall not be recruited, under any of the circumstances set forth below:
  - **Conflicting activities:** (i) a firm that has been engaged by the Client/Employer to provide goods, works or Assignment/job other than consulting Assignment/job for a project, and any of its affiliates, shall be disqualified from providing consulting Assignment/job related to those goods, works or Assignment/job. Conversely, a firm hired to provide consulting Assignment/job for the preparation or implementation of a project, and any of its affiliates, shall be disqualified from subsequently providing goods or works or Assignment/job other than consulting Assignment/job resulting from or directly related to the firm's consulting Assignment/job for such preparation or implementation. For the purpose of this paragraph, Assignment/job other than consulting to a measurable physical output, for example surveys, exploratory drilling, aerial photography, and satellite imagery.
  - Conflicting Assignment/job; (ii) A Consultant (including its Personnel and Sub-Consultants) or any of its affiliates shall not be hired for any Assignment/job that, by its nature, may be in conflict with another Assignment/job of the Consultant to be executed for the same or for another Client/Employer. For example, a Consultant hired to prepare engineering design for an infrastructure project shall not be engaged to prepare an independent environmental assessment for the same project, and a Consultant assisting an Client/Employer in the privatization of public assets shall not purchase, nor advice purchasers of, such assets. Similarly, a Consultant hired to prepare Terms of Reference for an Assignment/job shall not be hired for the Assignment/job in question.
  - **Conflicting relationships** (iii) A Consultant (including its Personnel and Sub-Consultants)that has a business or family relationship with a member of the Client/Employer's staff who is directly or indirectly involved in any part of (i) the preparation of the Terms of Reference of the Assignment/job, (ii) the selection process for such Assignment/job, or (iii) supervision of the Contract, may not be awarded a Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the Client/Employer throughout the selection process and the execution of the Contract.
- 5.3 Consultants have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of their Client/Employer, or that may reasonably be perceived as having this effect. Any such disclosure shall be made as per the Standard forms of technical proposal provided herewith. If the consultant fails to disclose said situations and if the Client/Employer comes to know about any such situation at any time, it may lead to the disqualification of the Consultant during bidding process or the termination of its Contract during execution of assignment.

5.4 No agency or current employees of the Client/Employer shall work as Consultants under their own ministries, departments or agencies.

#### 6. Unfair Advantage

6.1 If a Consultant could derive a competitive advantage from having provided consulting Assignment/job related to the Assignment/job in question and which is not defined as conflict of interest as per para 5 above, the Client/Employer shall make available together with this RFP all information that would in that respect give such Consultant any competitive advantage over competing Consultants.

#### 7. Proposal

7.1 Consultants may submit only one proposal. If a Consultant submits or participates in more than one proposal, such proposals shall be disqualified. However, this does not limit the participation of individual experts, to more than one proposal

#### 8. **Proposal Validity**

8.1 The Part II Data Sheet to consultant indicates how long Consultants' Proposals must remain valid after the submission date. During this period, Consultants shall maintain the availability of Professional staff nominated in the Proposal and also the financial proposal unchanged. The Client/Employer will make its best effort to complete negotiations within this period. Should the need arise; however, the Client/Employer may request Consultants to extend the validity period of their proposals. Consultants who agree to such extension shall confirm that they maintain the availability of the Professional staff nominated in the Proposal and their financial proposal remain unchanged, or in their confirmation of extension of validity of the Proposal, Consultants could submit new staff in replacement, which would be considered in the final evaluation for contract award. Consultants who do not agree have the right to refuse to extend the validity of their Proposals; under such circumstance the Client/Employer shall not consider such proposal for further evaluation.

#### 9. Preparation of Proposals

- 9.1 The Proposal as well as all related correspondence exchanged by the Consultants and the Client/Employer shall be written in English language, unless specified otherwise.
- 9.2 In preparing their Proposal, Consultants are expected to examine in detail the documents comprising the RFP. Material deficiencies in providing the information requested may result in rejection of a Proposal.
- 9.3 While preparing the Technical Proposal, Consultants must give particular attention to the following:

- (a) If a Consultant considers that it may enhance its expertise for the Assignment/job by associating with other Consultants, it may associate with other Consultant.
- (b) The estimated number of Professional staff-months for the Assignment/job is as shown in the *Part II Data sheet*. However, the Proposal shall be based on the number of Professional staff-months or budget estimated by the Consultants. While making the proposal, the consultant must ensure that he proposes the minimum number and type of experts as sought by the Client/Employer, failing which the proposal shall be considered as non-responsive.
- (c) Alternative professional staff shall not be proposed, and only one curriculum vita (CV) may be submitted for each position mentioned.
- 9.4 Depending on the nature of the Assignment/job, Consultants are required to upload and submit a Technical Proposal (TP) in forms provided in Section-III. The Part II Data sheet in Section-III indicates the formats of the Technical Proposal to be submitted. Submission of the wrong type of Technical Proposal will result in the Proposal being deemed non-responsive. The Technical Proposal shall provide the information indicated in the following paras from (a) to (g) using the attached Standard Forms (Section 3).Form Tech I in Section-III is a sample letter of technical proposal which is to be submitted along with the technical proposal.
  - A brief description of the consultant's organization and in the case of a consortium/ (a) joint venture, of each partner, will be provided in *Form Tech-2*. In the same Form, the consultant and in the case of a consortium/joint venture, each partner will provide details of experience of assignments which are similar to the proposed assignment/ job as per the terms of reference. For each Assignment/job, the outline should indicate the names of Professional staff who participated, duration of the Assignment/job, contract amount, and Consultant's involvement. Information should be provided only for those Assignment/jobs for which the Consultant was legally contracted by the Client/Employer as a corporation or as one of the major firms within a joint venture. Assignment/jobs completed by individual Professional staff working privately or through other consulting firms cannot be claimed as the experience of the Consultant, or that of the Consultant's associates, but can be claimed by the Professional staff themselves in their CVs The claimed experience in the proposal must be substantiated with letter of award / copy of contract for all the assignments mentioned in the proposal along with the certificate of Experience from the Principal Client.
  - (b) Comments and suggestions on the Terms of Reference including workable suggestions that could improve the quality/ effectiveness of the Assignment/job; and on requirements for counterpart staff and facilities including: administrative support, office space, Domestic transportation, equipment, data, etc. to be provided

by the *consultant (Form TECH-3 of Section 3)*.

- (c) A description of the approach, methodology and work plan for performing the Assignment/job covering the following subjects: technical approach and methodology, work plan, and organization and staffing schedule. Guidance on the content of this section of the Technical Proposals is provided under Form *TECH-4 of Section 3*. The work plan should be consistent with the *Work Schedule (Form TECH-8 of Section 3)* which will show in the form of a bar chart the timing proposed for each activity.
- (d) The list of the proposed Professional staff team by area of expertise, the position that would be assigned to each staff team member and their tasks is to be provided in *Form TECH-5 of Section 3*.
- (e) Estimates of the staff input needed to carry out the Assignment/job needs to be given in *Form TECH-7 of Section 3*. The staff-months input should be indicated separately for each location where the Consultants have to work and / or provide their key staff.
- (f) CVs of the Professional staff as mentioned in para 9.4 (d) above signed by the staff themselves or by the authorized representative of the *Professional Staff (Form TECH-6 of Section 3)*.
- (g) A detailed description of the proposed methodology and staffing for training needs to be given, if the Part II Data sheet specifies training as a specific component of the Assignment/job.
- 9.5 The Technical Proposal shall not include any financial information. A Technical Proposal containing financial information may be declared non responsive.
- 9.6 Financial Proposals: The *Financial Proposal* shall be prepared/uploaded using the attached *Standard Forms (Section 4)*. It shall list all costs associated with the Assignment/job, including (a) remuneration for staff and (b) reimbursable expenses indicated in the Part II Data sheet. If appropriate, these costs should be broken down by activity and, if appropriate, into foreign (if applicable) and domestic expenditures. The financial proposal shall not include any conditions attached to it and any such conditional financial proposal shall be rejected summarily.

#### 10. Taxes

10.1 The Consultant shall fully familiarize themselves about the applicable Domestic taxes (Goods and Service Tax (GST) and/or any other taxes as may be applicable for the time

being in force ) on amounts payable by the Client/Employer under the Contract. All such taxes must be included by the consultant in the financial proposal.

#### 11. Currency

11.1 Consultants shall express the price of their Assignment/job in Indian Rupees. [In case of assignment where payments in foreign currency are allowed to be made, the consultants are free to make their quote in any foreign currency. The Client/Employer shall mention the provision regarding conversion of such foreign currency to Indian Rupees]

#### 12. Earnest Money Deposit (EMD)

- 12.1 Earnest Money Deposit (EMD)
  - I. An *EMD* of amount as mentioned in data sheet, in the form of DD/ Bank Guarantee drawn in favour of *Shimla Smart City Limited* and payable at *Shimla* as mentioned in data sheet, must be submitted along with the Proposal.
  - II. Proposals not accompanied by *EMD* shall be rejected as non-responsive.
  - III. No interest shall be payable by the Client/Employer for the sum deposited as earnest money deposit.
  - IV. No bank guarantee will be accepted in lieu of the earnest money deposit.
  - V. The EMD of the unsuccessful bidders would be returned back within one month of signing of the contract.
- 12.2 The *EMD* shall be forfeited by the Client/Employer in the following events:
  - I. If Proposal is withdrawn during the validity period or any extension agreed by the consultant thereof.
  - II. If the Proposal is varied or modified in a manner not acceptable to the Client/Employer after opening of Proposal during the validity period or any extension thereof.
  - III. If the consultant tries to influence the evaluation process.
  - IV. If the First ranked consultant withdraws his proposal during negotiations (failure to arrive at consensus by both the parties shall not be construed as withdrawal of proposal by the consultant).

#### 13. Bid Processing Fees/Cost of Tender

All consultants are required to pay as mentioned in data sheet towards *Bid Processing Fees* in the form of demand Draft drawn in favour of *Shimla Smart City Limited* and payable at *Shimla* (as indicated in Data Sheet). The Bid Processing Fee is Non-Refundable. Non submission of Bid Processing fee along with the Technical Proposal will be treated as non-responsive bid.

#### 14. Submission, Receipt, and Opening of Proposal

- 14.1 These instructions should be read in conjunction with information specific to the consulting services contained in the Covering Letter, Data Sheet and accompanying documents.
- 14.2 The Original Proposals (Technical Proposal); shall be *submitted physically* and password protected copy *uploaded electronically online*.
- 14.3 Bidder shall also submit the following documents in separate envelopes and marked as indicated below.
  - *Envelope 1* containing Cost of RFP/ Bid Processing Fee as prescribed in Data Sheet in Original;
  - *Envelope 2* Earnest Money Deposit (EMD)as prescribed in Data Sheet in Original;
  - *Envelope 3* containing the Original Technical Proposal;
- 14.4 An authorized representative of the Firm initials all pages of the Proposal submitted in hard copy. The representative's authorization is confirmed by a written power of attorney accompanying the proposals.
- 14.5 The scanned copies of DD of cost of RFP and DD/BG of EMD and scanned copy of original technical proposal and financial proposal (BOQ to be filled online) must be uploaded online on or before the time and date Stated in the data sheet. All submission shall be in PDF (portable document format).
- 14.6 After the deadline for submission of proposals the technical proposal shall be downloaded/ opened immediately by the Authorized representative of *Shimla Smart City Limited* [SSCL]. The financial proposal shall remain encrypted until technical proposals are evaluated by the client.

- 14.7 A consultant should submit only one proposal. If a consultant submits or participate in more than one proposal such a consultant shall be disqualified.
- 14.8 The tenders shall be rejected outrightly if:
  - a) Tender is in the name of person or firm who is not a consulting firm.
  - b) Tender fees and Earnest Money Deposit not received in the time as prescribed in the RFP.
  - c) If the consultant has quoted rates with additional condition and counter conditions
  - d) In case of any deviation in the terms of reference, terms and conditions of the tender.
  - e) If the "*Technical Bid*" of any firm is decided as non-responsive, the "*Price Bid*" of that firm shall not be opened
  - f) If the rates are unworkable.

#### 15. Proposal Evaluation

- 15.1 From the time the Proposals are opened till the time the Contract is awarded, the Consultants should not contact the Client/Employer on any matter related to its Technical and/or Financial Proposal. Any effort by Consultants to influence the Client/Employer in the examination, evaluation, ranking of Proposals, and recommendation for award of Contract may result in the rejection of the Consultants' Proposal.
- 15.2 The Client/Employer will constituted a Consultant Selection Committee (CSC) which will carry out the entire evaluation process.
- 15.3 **Evaluation of Technical Proposals:** CSC while evaluating the Technical Proposals shall have no access to the Financial Proposals until the technical evaluation is concluded and the competent authority accepts the recommendation.
- 15.4 The CSC shall evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and by applying the evaluation criteria, sub-criteria specified in the Data sheet. In the first stage of evaluation, a Proposal shall be rejected if it is found deficient as per the requirement indicated in the Data sheet for responsiveness of the proposal. Only responsive proposals shall be further taken up for evaluation. Evaluation of the technical proposal will start first and at this stage the financial bid (proposal) will remain **unopened**. The qualification of the consultant and the evaluation criteria for the technical proposal shall be as defined in the Data sheet.
- 15.5 **Public opening & evaluation of the Financial Proposals:** Financial proposals of only those firms who are technically qualified shall be opened publicly on the date & time specified the Data sheet, in the presence of the Consultants' representatives who choose to attend. The name of the Consultants, their technical score (if required) and their financial proposal shall be read aloud.

- 15.6 The CSC will correct any computational errors. When correcting computational errors, in case of discrepancy between a partial amount and the total amount, or between word and figures, the former will prevail. In addition to the above corrections the items described in the Technical Proposal but not priced, shall be assumed to be included in the prices of other activities or items. In case an activity or line item is quantified in the Financial Proposal differently from the Technical Proposal, (i) if the Time-Based form of contract has been included in the RFP, the Evaluation Committee shall correct the quantification indicated in the Financial Proposal so as to make it consistent with that indicated in the Technical Proposal, apply the relevant unit price included in the Financial Proposal to the corrected quantity and correct the total Proposal cost, (ii) if the Lump-Sum form of contract has been included in the RFP, no corrections are applied to the Financial Proposal in this respect. If permitted under RFP to quote in any currency other than Indian Rupees, prices shall be converted to Indian Rupees using the selling rates of exchange, source and reference date indicated in the Data sheet. Normally, the date will be the date of opening of the tender unless specified otherwise in the Data sheet.
- 15.7 After opening of financial proposals, appropriate selection method shall be applied to determine the consultant who will be declared winner and be eligible for award of the contract. The methods of selections are described in the Data Sheet [The Client/Employer shall mention here which method out of all listed method shall be applied for selection of consultant for this assignment / job]. This selected consultant will then be invited for negotiations, if considered necessary.

#### 16. Negotiations

- 16.1 Negotiations will be held at the date, time and address intimated to the qualified and selected bidder. The invited Consultant will, as a pre-requisite for attendance at the negotiations, confirm availability of all Professional staff. Representatives conducting negotiations on behalf of the Consultant must have written authority to negotiate and conclude a Contract.
- 16.2 **Technical negotiations:** Negotiations will include a discussion of the Technical Proposal, the proposed technical approach and methodology, work plan, and organization and staffing, and any suggestions made by the Consultant to improve the Terms of Reference. The Client/Employer and the Consultants will finalize the Terms of Reference, staffing schedule, work schedule, logistics, and reporting. These documents will then be incorporated in the Contract as "*Description of Assignment/job*". Special attention will be paid to clearly defining the inputs and facilities required from the Client/Employer to ensure satisfactory implementation of the Assignment/job. The Client/Employer shall prepare minutes of negotiations which will be signed by the Client/Employer and the Consultant.
- 16.3 Financial negotiations: After the technical negotiations are over, financial negotiations

should be carried out in order to reflect any change in financials due to change in scope of work or due to clarification on any aspect of the technical proposal during the technical negotiations. Under no circumstance, the financial negotiation shall result in to increase in the price originally quoted by the consultant. Unless there are exceptional reasons, the financial negotiations will involve neither the remuneration rates for staff nor other proposed unit rates. For other methods, Consultants will provide the Client/Employer with the information on remuneration rates described in the Appendix attached to *Section 4 - Financial Proposal - Standard Forms of this RFP*.

- 16.4 Availability of Professional staff/experts: Having selected the Consultant on the basis of, among other things, an evaluation of proposed Professional staff, the Client/Employer expects to negotiate a Contract on the basis of the Professional staff named in the Proposal. Before contract negotiations, the Client/Employer will require assurances that the Professional staff will be actually available. The Client/Employer will not consider substitutions during contract negotiations unless both parties agree that undue delay in the selection process makes such substitution unavoidable or for reasons such as death or medical incapacity or if the professional staff were offered in the proposal without confirming their availability, the Consultant may be disqualified. Any proposed substitute shall have equivalent or better qualifications and experience than the original candidate and be submitted by the Consultant within the period of time specified in the letter of invitation to negotiate.
- 16.5 Conclusion of the negotiations: Negotiations will conclude with a review of the draft Contract. To complete negotiations the Client/Employer and the Consultant will initial the agreed Contract. If negotiations fail, the Client/Employer may invite the next lowest bidder for negotiation or invite fresh proposals
- 16.6 If any key expert gets less than specified marks in the Data Sheet during technical evaluation, then he/she needs to be replaced at the time of negotiation. The other experts whose CVs will not be evaluated but has to be submitted with proposal, should meet the minimum qualification criteria as per the ToR, otherwise such expert also needs to be replaced at the time of negotiation.

#### 17. Award of Contract

- 17.1 After completing negotiations the Client/Employer shall issue a Letter of Intent to the selected Consultant and promptly notify all other Consultants who have submitted proposals about the decision taken.
- 17.2 The consultants will sign the contract after fulfilling all the formalities/pre-conditions including Performance Guarantee as mentioned in the standard form of contract in *Section-6*, within 10 days of issuance of the letter of intent.

17.3 The Consultant is expected to commence the Assignment/job on the date and at the location specified in the *Part II Data Sheet*.

#### 18. Confidentiality

- 18.1 Information relating to evaluation of Proposals and recommendations concerning awards shall not be disclosed to the Consultants who submitted the Proposals or to other persons not officially concerned with the process, until the publication of the award of Contract. The undue use by any Consultant of confidential information related to the process may result in the rejection of its Proposal and may be subject to the provisions of the Client/Employer's antifraud and corruption policy.
- 19 The Client/Employer reserves the right to verify all statements, information and documents submitted by the Applicant in response to the RFP. Any such verification or the lack of such verification by the Client/Employer to undertake such verification shall not relieve the Applicant of its obligation or liabilities here under nor will it affect any rights of the Client/Employer here under.

#### 20 Sub Contracting

The Consultant may sub-contract part of the Services subject to clause 5 of the RFP with prior approval of the Client/Employer.

#### 21 **Project Duration**

The total duration of the contract shall be 36 (Thirty Six) months. The contract may be extended if required by the Shimla Smart City Limited on the same term and conditions under original agreement subject to satisfactory performance of the Consultant and achieving milestones successfully, and subject to the condition that after initial term of 36 months the scope of work and requirement of Key Professional and Support staff and their man months is reviewed and revised by the Shimla Smart City Limited. The person –day rates shall be revised mutually upto maximum 10% increase for the remuneration of Key Professionals and Support Staff required by the Shimla Smart City Limited which shall be applicable for next period of extension.

22 The selection process shall be governed and construed in accordance with the laws of India and Courts at *Shimla* shall have exclusive jurisdiction and all disputes arising under pursuant to and/or in connection with the Selection Process.



- 1 **Form FIN-1** Financial Proposal Submission Form shall be filled as per the instructions provided in the Form.
- 2 **Form FIN-2** Summary of Costs: Form FIN-2 provides a summary of the elements of estimated costs for implementation of the proposed Consultant services.

#### 3 Form FIN-3 (A) and 3(B) Remuneration

- (i) The purpose of Form FIN-3A&3B is to identify the monthly billing rates for each Personnel to be fielded by the Consultant as part of its proposed team of experts.
- (ii) Months; number of months input to match that shown on the personnel schedule (Form TECH-7, Section 3). Please note that the man month for Time Based components shall be equal to that mentioned in ToR. The month shall be calculated as per follows:

1 year = 12 months = 252 working days

(iii) Support Staff is also included in this form.

#### 4 Form FIN-4(A) and 4 (B) – Reimbursable Expenses

The purpose of Form FIN-4 A &4B is to identify all reimbursable expenditures in local currencies considered by the Consultant necessary to carry out the assignment.

(i) Per Diem allowance

The Per Diem allowance shall be paid for stay requirements outside Home Office (Office (Central or Project city assigned to the Personnel) night for night spent away outside Home Office during such travel. The travel shall be undertaken with prior consent of the Client. The payment will be made on lump sum basis without any supporting vouchers.

(ii) Office Operations

The Consulting firm is required to quote expenses for office expenses towards office operation and maintenance including all consumables and documentations as required for the project. The monthly payment shall be made on lump sum basis without any supporting vouchers.

(iii) Office Accommodation

This shall be applicable only in case the office accommodation is not provided by the Project City or Central Office. The Consulting firm is required to quote rental value of accommodation for Office. The monthly payment shall be made on actual basis on submission of supporting vouchers.

#### (iv) Local Transport

The Consulting firm is required to quote expenses for local transportation at central and project office as required for the project. The monthly payment shall be made on lump sum basis with proof of availability of vehicle. The arrangement to be finalise at Contract Negotiations.

#### (iv) Communication Costs

The Consulting firm is required to quote expenses for Communication Costs to all personnel and office as required for the project. The arrangement for lump sum basis or on actual to be finalise at Contract Negotiations.

#### (iv) Report Production

The Consulting firm is required to quote lump sum expenses for Report Production as required for the project. The arrangement for payments be finalise at Contract Negotiations.

#### 5. Provisional Sums and Contingencies (Form FIN 5)

All expenditures under the project, which are to be paid under provisional sums on actual basis, shall be done maintaining financial proprietary. The Financial proprietary means purchasing of any article from open market on most competitive rates based on at least three quotations or by calling tenders. Consulting firm has to provide certificate that material is purchased on lowest rate in the market.

All equipment, furniture items, documents, reports and other articles purchased by the Consultant from the project fund shall be property of Client. At the end of Contract, the firm will hand over all these articles and equipment in working conditions to the Client. Proper stock register of purchases and store articles shall be maintained by firm and shall be made available for stock verifications as required. Following expenditures shall fall under provisional sums and shall be reimbursed on actual basis.

#### a. Office equipment

All necessary office equipment and furniture like computer hardware, printers, software, networking devices, maintenance & up-gradation of the system, fax machines, EPABX, photocopier, ACs, chairs, tables etc. as applicable under project shall be purchased by the consulting firm. The firm will assess the requirement and specifications of the equipment to be procured and have these approved by Client before purchase.

#### b. Workshops and seminars

The expenditures made on meetings, seminars and workshops etc. with the approvals of Shimla Smart City Limited shall be reimbursed based on actual.

#### c. Intercity travel

The cost of vehicle transportation (Four wheeler on hire) for miscellaneous travels required for intercity travel for performance of the work, etc. The cost of transport for personnel by AC sleeper or AC Chair-car by trains / deluxe buses/ flight required for performance of the services to visit the other towns and attend IIIrd party inspections etc. with the approval of Shimla Smart City Limited. The payment will be considered for actual number of trips desired by the Shimla Smart City Limited. for performance of services and will be reimbursed on the actual basis from provisional sum.

#### 6. Contingencies

The provision of contingencies shall be there as indicated.

# Section 5: Terms of Reference

#### 1. Background

1. Shimla Smart City Proposal was prepared based upon the priorities identified by *direct engagement with 1,01,561 (57 percent) citizens* of the city by means of individual Feedback forms, SMS reply, Facebook, MyGov online engagement and Ward Sabha meetings. The citizen engagement process led to the identification of the following top priority areas:

- (i) Traffic congestion, Public transport, Parking and Pedestrian mobility.
- (ii) Potable water supply.
- (iii) Solid waste and Waste water management.
- (iv) Building safety, Disaster mitigation and Security of citizens.
- (v) Open and recreational spaces.

As per the Smart City Mission guidelines, the identified top priority areas have been addressed in the Smart City Proposal through detailed deliberation, resulting in various *Inter-Departmental Projects*. The Final Proposal was approved by the State Level High Powered Steering Committee (HPSC) before submission to Govt. of India. Government of India has announced the list 30 cities including Shimla to be taken up for development of Smart cities in 3<sup>rd</sup> round. The resulting projects which are to be implemented through the *Special Purpose Vehicle (SPV*), have been divided under the following main parts:-

#### TOTAL COST OF SHIMLA SMART CITY PROPOSAL

The strength of the Shimla Smart City proposal lies in its *commercial viability*, arising out of the stress laid on the tourism industry; which is also the mainstay of the people of the city. The proposal lays emphasises on *raising the standard* of living of the common citizen and improved tourist experience. The smartness of the proposal lies in various *frugal innovative measures and smart initiatives* aimed at the successful implementation of various projects, such as:

- (i) Urban Knowledge Centre and Skill Development Centre.
- (ii) Shift to mileage based bus transit system (OPEX Model).
- (iii) Net metering of Solar energy.
- (iv) Precast hollow block unit to recycle construction debris.
- (v) Global best PPP standards and Contracting practices.
- (vi) Radio station for disaster communication & continued citizen participation.

#### 2. Objective of the Assignment

2. The objective of the assignment is to provide direct assistance to *Shimla Smart City Limited* of the *Shimla* to design develop, manage and implement Smart City Projects as per para 10.6 of Smart City Mission Guidelines.

#### 3. Scope of Services

3.1 The scope of PMC under the proposed mission will be divided into three broad components namely (i) Project Management, (ii) Design & Development and (iii) Supervision.

3.2 The Consultant shall support the *Shimla Smart City Limited* of the *Shimla* in overall project management of Smart City projects, including designing, developing, managing and implementing smart city projects identified by the city on the following two outputs:

- (i) Output1: Area Based Development
- (ii) Output2: Pan-city Solution

3.3 Under this assignment the consultant is required to review projects identified by the Smart City, for Area Based Development as well as for Pan City Solution (Smart City Proposal Can be downloaded Smart mission from the website Citv of http://smartcities.gov.in/upload/uploadfiles/files/Final-Shimla-Scp.pdf). The project detail (module wise) as mentioned in Smart City Proposal is attached at Annexure I for reference. The projects identified in this list are to be vetted in consultation with stakeholders with regard to the technical and economic feasibility and sustainability etc. Therefore projects may change so as to align and adapt with mission objective in consultation with the stakeholders/Client/Employer. The consultant will carry out required investigations, design, prepare feasibility report, Preliminary Design Report/ Detail Design Report (PDR/DPR), and assist in procurement of implementing partner/agency(ies) expeditiously. The PMC shall assist SPV in preparation of RFPs for the procurement of implementing partner(s)/ Agency(ies).

3.4 The PMC shall also assist the *Shimla Smart City Limited* in supervision & monitoring of the work of implementing agencies and shall be responsible for overall management of the project.

3.5 The RFPs prepared by the PMC for procurement of implementing partner/agency(ies) for implementation of Smart City Projects, will follow International Competitive Bidding (ICB) method. The Shimla Smart City Limited will decide on method of procurement such QCBS, QBLCS (Quality Based Least Cost Selection) etc.

3.6 PMC shall operate full-fledged with all its Key Experts and Supporting Staff from their Project Office in Shimla.

3.7 Without limiting the scope, the PMC shall be responsible for the following tasks:

#### 4. Detailed Scope of Work:

#### A. Task 1: Project Management:

#### I. Activity 1:

- i. The team leader of the consultant shall initially mobilize the core team following notice to proceed to set up project office along with equipment and peripherals and then will mobilize further manpower as per requirement for each module.
- ii. Handhold/ support *Shimla Smart City Limited* for project identification and prioritization, investigations, design, procurement, supervision, cost control, scheduling, risk management, monitoring, auditing, reporting, and ensuring compliances and due diligences required for the project;
- iii. Planning, scheduling and monitoring of the projects using PMIS / latest IT tools and techniques such as online monitoring of work sites with the aid of cyber tools.
- iv. Assist *Shimla Smart City Limited* in identifying key stakeholders, (such as from elected representatives, eminent persons, sector experts, RWAs, market associations, government entities, institutions, etc.) and conducting regular meetings to discuss progress and issues related to smart city projects, and prepare minutes for recording and circulation;
- v. Establish all necessary records and the procedures of maintaining/updating such records for each package and for the entire project.
- vi. Develop and implement procedure for timely payments to the contractors and monitor for compliance;
- vii. Monitor implementation of mitigation measures for the project, and update the Plan as per requirement.

- vii. Review the available GIS maps and integrate to the possible extent to develop area wise spatial mapping on assets.
- viii. Preparation of situation analysis report for each module.

#### b. Pan City Proposal

- i. Review existing available documents & infrastructure on the proposed smart solution and integrate them into modules.
- ii. Consult Advance Concept Notes of each project available with Shimla Smart City Limited.

approval of the Smart City/SPV. The costs estimate shall be prepared on the basis of Rates suggested by SPV such as SOR of State with latest addenda and corrigenda And/or market rates would be arrived at proper rate analysis carried out through market enquiry;<sup>4</sup>

- ii. The design shall meet the techno economic aspects for the best possible solutions after considering various alternatives and shall be sufficiently detailed to ensure understanding by all stake holders and will be incorporated into the detailed Project Report. The activities for the proposed project shall include preliminary designs, drawings, works technical specifications, bill of quantities, and cost estimates (Engineer's Cost) based on Schedule of Rates of the state and/or market rate analysis, along with detailed implementation plans. Technologies used, best practices used. High level architecture document. Process used for design development, test and support.
- iii. For each sub project based on the approved frame work the following shall be included in the DPRs:
  - Assessment of utility shifting requirement and costs estimations; preparing document required for statutory clearances and other clearances like Railway, Forest, National Highways, Health, Transport, Police, Fire, HRTC etc;
  - Assess each site's environmental aspects for detailed design of the project component. Accordingly prepare initial environmental impact examinations (IEE) as may be required;

- 4. The draft contract to be included in the bid documents shall, among other things, clearly define the obligations of the implementing agency with respect to financing( if applicable), design, construction, O&M, and tariffs; equitably allocate risks between the parties; and specify rules and procedures to address non- performance of contractual obligations.

- p) Monitoring the performance of the overall system in terms of availability & efficiency against the service levels already defined for SI
- q) Suggest corrective and preventive measures to SPV and SI to enhance the performance of the system
- r) Coordinate with all the stakeholders and support the state departments while interacting with various agencies (internal and external) during the course of the project.
- s) Build mechanisms to ensure coordination and consultation between all key stakeholders and members of the SPV on a continued basis to facilitate the execution of the project.
- ii. Monitoring the deployment and commissioning of necessary hardware

# 1. General Provisions

**1.1 Definitions** Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

(a) "Applicable Law" means the laws and any other instruments having the force of law in India for the time being.

(b) "Consultant" means any private or public entity that will provide the Services to the Client/Employerunder the Contract.

(c) "Contract" means the Contract signed by the Parties and all the attached documents listed in its Clause 1, that is this General Conditions (GC), the Special Conditions (SC), and the Appendices.

(d) "Day" means calendar day.

(e) "Effective Date" means the date on which this Contract comes into force and effect pursuant to Clause GC 2.1.

(f) "Foreign Currency" means any currency other than the currency of the Client/Employer's country.

(g) "GC" means these General Conditions of Contract.

(h) "Government" means the Government of India

(i) "Local Currency" means Indian Rupees.

(j) "Member" means any of the entities that make up the joint venture/consortium/association; and "Members" means all these entities.

(k) "Party" means the Client/Employe or the Consultant, as the case may be, and "Parties" means both of them.

(1) "Personnel" means professionals and support staff provided by the Consultants or by any Sub-Consultants and assigned to perform the Services or any part thereof; "Foreign Personnel" means such professionals and support staff who at the time of being so provided had their domicile outside the Government's country; "Local Personnel" means such professionals and support staff who at the time of being so provided had their domicile inside the Government's country; and "Key Personnel" means the Personnel referred to in Clause GC 4.2(a).

(m) "Reimbursable expenses" means all assignment-related costs [such as travel, translation, report printing, secretarial expenses, subject to specified maximum limits in the Contract].

(n) "SC" means the Special Conditions of Contract by which the GC may be amended or supplemented.

(o) "Services" means the work to be performed by the Consultant pursuant to this Contract, as described in Appendix A hereto.

(p) "Sub-Consultant" means any person or entity with whom, the Consultant subcontracts any part of the Assignment/job subject to the clause 5 of this RFP relating to conflict of interest with prior approval of the Client/Employer.

(q) "Third Party" means any person or entity other than the Client/Employer, or the Consultant.

(r) "In writing" means communicated in written form with proof of receipt.

**1.2 Relationship Between the Parties :** Nothing contained herein shall be construed as establishing a relationship of master and servant or of principal and agent as between the Client/Employer and the Consultant. The Consultant, subject to this Contract, has complete charge of Personnel and Sub-Consultants, if any, performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

- **1.3 Law Governing Contract:** This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the applicable laws of India.
- **1.4 Headings:** The headings shall not limit, alter or affect the meaning of this Contract.

# 1.5 Notices

- 1.5.1 Any notice, request or consent required or permitted to be given or made pursuant to this Contract shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent by registered post to such Party at the address specified in the SC.
- 1.5.2 A Party may change its address for notice hereunder by giving the other Party notice in writing of such change to the address specified in the SC.

**1.6** Location: The Services shall be performed at such locations as are specified in Appendix A hereto and, where the location of a particular task is not so specified, at such locations, as the Client/Employermay approve.

**1.7 Authority of Lead Partner:** In case the Consultant consists of a joint venture/consortium/ association of more than one entity, the Members hereby authorize the entity specified (Lead Consultant) in the SC to act on their behalf in exercising all the Consultant's rights and obligations towards the Client/Employer under this Contract, including without limitation the receiving of instructions and payments from the Client/Employer. However, each member or constituent of Consortium of Consultant shall be jointly and severally liable for all obligations of the Consultant under the Contract.

**1.8** Authorized Representatives: Any action required or permitted to be taken, and any document required or permitted to be executed under this Contract by the Client/Employer or the Consultant may be taken or executed by the officials specified in the SC.

**1.9** Taxes and Duties: The Consultant, Sub-Consultants and Personnel shall be liable to pay such direct and indirect taxes, duties, fees and other impositions levied under the applicable laws of India.

# **1.10** Fraud and Corruption

**1.10.1 Definitions:** It is the Client/Employer's policy to require that Client/Employers as well as Consultants observe the highest standard of ethics during the execution of the Contract. In pursuance of this policy, the Client/Employer defines, for the purpose of this provision, the terms set forth below as follows:

(i) "Corrupt practice" means an offering, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the selection process or in contract execution;

(ii) "Fraudulent practice" means a misrepresentation or omission of facts in order to influence a selection process or the execution of a contract;

(iii) "Collusive practices" means a scheme or arrangement between two or more consultants, with or without the knowledge of the Client/Employer, designed to establish prices at artificial, non-competitive levels;

 (iii) "coercive practices" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process, or affect the execution of a contract;

# 1.10.2 Measures to be taken by the Client/Employer

(a) The Client/Employer may terminate the contract if it determines at any time that representatives of the consultant were engaged in corrupt, fraudulent, collusive or coercive practices during the selection process or the execution of that contract, without the consultant having taken timely and appropriate action satisfactory to the Client/Employer to remedy the situation;

(b) The Client/Employer may also sanction against the Consultant, including declaring the Consultant ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that the Consultant has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for, or in executing, an Client/Employer-financed contract;

# 1.10.3 Commissions and Fees

At the time of execution of this Contract, the Consultants shall disclose any commissions or fees that may have been paid or are agreed to be paid to agents, representatives, or commission agents with respect to the selection process or execution of the contract. The information disclosed must include at least the name and address of the agent, representative, or commission agent, the amount and currency, and the purpose of the commission or fee.

# 2. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF CONTRACT

**2.1 Effectiveness of Contract:** This Contract shall come into force and effect on the date (the "Effective Date") of the Client/Employer's notice to the Consultant instructing the Consultant to begin carrying out the Services. This notice shall confirm that the conditions precedent and effectiveness conditions, if any, listed in the SC have been met.

**2.2** Termination of Contract for Failure to Become Effective: If this Contract has not become effective within such time period after the date of the Contract signed by the Parties as specified in the SC, either Party may, by not less than twenty one (21) days written notice to the other Party, declare this Contract to be null and void, and in the event of such a declaration by either Party, neither Party shall have any claim against the other Party with respect hereto.

**2.3** Commencement of Services: The Consultant shall begin carrying out the Services not later than the number of days after the Effective Date as specified in the SC.

**2.4** Expiration of Contract: Unless terminated earlier pursuant to Clause GC 2.9 hereof, this Contract shall expire at the end of such time period after the Effective Date as specified in the SC.

**2.5 Entire Agreement:** This Contract contains all covenants, stipulations and provisions agreed by the Parties. No agent or representative of either Party has authority to make, and the Parties shall not be bound by or be liable for, any other statement, representation, promise or agreement not set forth herein.

**2.6 Modifications or Variations:** (a) any modification or variation of the terms and conditions of this Contract, including any modification or variation of the scope of the Services, may only be made by written agreement between the Parties. Pursuant to Clause GC 7.2 here of, however, each Party shall give due consideration to any proposals for modification or variation made by the other Party. (b) In cases of substantial modifications or variations, the prior written consent of the Client/Employer is required.

# 2.7 Force Majeure

**2.7.1 Definition** (a) For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable and not brought about by or at the instance of the Party claiming to be affected by such events and which has caused the non-performance or delay in performance, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other extreme adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by Government agencies.

(b) Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or by or of such Party's Sub-Consultants or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected both to take into account at the time of the conclusion of this Contract, and avoid or overcome in the carrying out of its obligations hereunder.

(c) Subject to clause 2.7.2, Force Majeure shall not include insufficiency of funds or inability to make any payment required hereunder.

**2.7.2** No Breach of Contract: The failure of a Party to fulfil any of its obligations hereunder shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Contract.

**2.7.3** Measures to be taken: (a) A Party affected by an event of Force Majeure shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall take all reasonable measures to minimize the consequences of any event of Force Majeure.

(b) A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any case not later than fourteen (14) days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible.

(c) Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

(d) During the period of their inability to perform the Services as a result of an event of Force Majeure, the Consultant, upon instructions by the "Client/Employer", shall either:

(i) Demobilize, or

(ii) Continue with the Services to the extent possible, in which case the Consultant shall continue to be paid proportionately and on prorata basis, under the terms of this Contract.

(e) In the case of disagreement between the Parties as to the existence or extent of Force Majeure, the matter shall be settled according to Clause GC 8.

**2.8 Suspension:** The Client/Employer may, by written notice of suspension to the Consultant, suspend all payments to the Consultant hereunder if the Consultant fails to perform any of its obligations under this Contract, including the carrying out of the Services, provided that such notice of suspension (i) shall specify the nature of the failure, and (ii) shall allow the Consultant to remedy such failure, if capable of being remedied, within a period not exceeding thirty (30) days after receipt by the Consultant of such notice of suspension.

# 2.9 Termination

**2.9.1.1 by the Client/Employer:** The Client/Employer may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (h) of this Clause GC 2.9.1.1

(a) If the Consultant fails to remedy a failure in the performance of its obligations hereunder, as specified in a notice of suspension pursuant to Clause GC 2.8 hereinabove, within thirty (30) days of receipt of such notice of suspension or within such further period as the Client/Employer may have subsequently approved in writing.

(b) If the Consultant becomes (or, if the Consultant consists of more than one entity, if any of its Members becomes and which has substantial bearing on providing Services under this contract) insolvent or go into liquidation or receivership whether compulsory or voluntary.

(c) If the Consultant fails to comply with any final decision reached as a result of arbitration proceedings pursuant to Clause GC 8 hereof.

(d) If the Consultant, in the judgment of the Client/Employer, has engaged in corrupt or fraudulent practices in competing for or in executing this Contract.

(e) If the Consultant submits to the Client/Employer a false statement which has a material effect on the rights, obligations or interests of the Clien/Client/Employer.

(ee) If the Consultant places itself in position of conflict of interest or fails to disclose promptly any conflict of interest to the Client/Employer.

(f) If the consultant fails to provide the quality services as envisaged under this Contract. The Consultancy Monitoring Committee (CMC) formulated to monitor the progress of the assignment may make judgment regarding the poor quality of services, the reasons for which shall be recorded in writing. The CMC may decide to give one chance to the consultant to improve the quality of the services.

(g) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) days.

(h) If the Client/Employer, in its sole discretion and for any reason whatsoever, decides to terminate this Contract.

2.9.1.2 In such an occurrence the Client/Employer shall give a not less than thirty (30) days' written notice of termination to the Consultants, and sixty (60) days' in case of the event referred to in (h).

**2.9.2 By the Consultant:** The Consultant may terminate this Contract, by not less than thirty (30) days' written notice to the Client/Employer, in case of the occurrence of any of the events specified in paragraphs (a) through (d) of this Clause GC 2.9.2.

(a) If the Client/Employer fails to pay any money due to the Consultant pursuant to this Contract and not subject to dispute pursuant to Clause GC 8 hereof within forty-five (45) days after receiving written notice from the Consultant that such payment is overdue.

(b) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) days.

(c) If the Client/Employer fails to comply with any final decision reached as a result of arbitration pursuant to Clause GC 8 hereof.

(d) If the Client/Employer is in material breach of its obligations pursuant to this Contract and has not remedied the same within forty-five (45) days (or such longer period as the Consultant may have subsequently approved in writing) following the receipt by the Client/Employer of the Consultant's notice specifying such breach. **2.9.3 Cessation of Rights and Obligations:** Upon termination of this Contract pursuant to Clauses GC 2.2 or GC 2.9 hereof, or upon expiration of this Contract pursuant to Clause GC 2.4 hereof, all rights and obligations of the Parties hereunder shall cease, except (i) such rights and obligations as may have accrued on the date of termination or expiration, (ii) the obligation of confidentiality set forth in Clause GC 3.3 hereof, (iii) the Consultant's obligation to permit inspection, copying and auditing of their accounts and records set forth in Clause GC 3.6 hereof, and (iv) any right which a Party may have under the Law.

**2.9.4** Cessation of Services: Upon termination of this Contract by notice of either Party to the other pursuant to Clauses GC 2.9.1 or GC 2.9.2 hereof, the Consultant shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. With respect to documents prepared by the Consultant and equipment and materials furnished by the "Client/Employer", the Consultant shall proceed as provided, respectively, by Clauses GC 3.9 or GC 3.10 hereof.

**2.9.5 Payment upon Termination:** Upon termination of this Contract pursuant to Clauses GC 2.9.1 or GC 2.9.2 hereof, the Client/Employer shall make the following payments to the Consultant:

(a) If the Contract is terminated pursuant to Clause 2.9.1 (g), (h) or 2.9.2, remuneration pursuant to Clause GC 6.3(h) (i)hereof for Services satisfactorily performed prior to the effective date of termination, and reimbursable expenditures pursuant to Clause GC 6.3(h)(ii) hereof for expenditures actually and reasonably incurred prior to the effective date of termination;

(b) If the agreement is terminated pursuant of Clause 2.9.1 (a) to (f), the consultant shall not be entitled to receive any agreed payments upon termination of the contract. However, the Client/Employer may consider to make payment for the part satisfactorily performed on the basis of Quantum Meruit as assessed by it, if such part is of economic utility to the Client/Employer. Applicable Under such circumstances, upon termination, the client may also impose liquidated damages as per the provisions of Clause 9 of this agreement. The consultant will be required to pay any such liquidated damages to client within 30 days from the termination date.

**2.9.6 Disputes about Events of Termination:** If either Party disputes whether an event specified in paragraphs (a) through (g) of Clause GC 2.9.1 or in Clause GC 2.9.2 hereof has occurred, such Party may, within forty-five (30) days after receipt of notice of termination from the other Party, refer the matter to Clause GC 8 hereof, and this Contract shall not be terminated on account of such event except in accordance with the terms of any resulting arbitral award.

# 3. OBLIGATIONS OF THE CONSULTANT

# 3.1 General

**3.1.1 Standard of Performance:** The Consultant shall perform the Services and carry out their obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology and safe and effective equipment, machinery, materials and methods. The Consultant shall always act, in respect of any matter relating to this Contract or to the Services, as faithful adviser to the Client/Employer, and shall at all times support and safeguard the "Client/Employer's legitimate interests in any dealings with Sub-Consultants or Third Parties.

**3.2 Conflict of Interests:** The Consultant shall hold the "Client/Employer's interests paramount, without any consideration for future work, and strictly avoid conflict of interest with other assignments or their own corporate interests. If during the period of this contract, a conflict of interest arises for any reasons, the Consultant shall promptly disclose the same to the Client/Employer and seek its instructions.

**3.2.1** Consultant not to benefit from Commissions, Discounts, etc.: (a)The payment of the Consultant pursuant to Clause GC 6 hereof shall constitute the Consultant's only payment in connection with this Contract and, subject to Clause GC 3.2.2 hereof, the Consultant shall not accept for its own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Contract or in the discharge of its obligations hereunder, and the Consultant shall use its best efforts to ensure that any Sub-Consultants, as well as the Personnel and agents of either of them, similarly shall not receive any such additional payment.

(b) Furthermore, if the Consultant, as part of the Services, has the responsibility of advising the Client/Employer on the procurement of goods, works or services, the Consultant shall comply with the Client/Employer's applicable procurement guidelines, and shall at all times exercise such responsibility in the best interest of the Client/Employer. Any discounts or commissions obtained by the Consultant in the exercise of such procurement responsibility shall be for the account of the "Client/Employer".

**3.2.2** Consultant and Affiliates Not to Engage in Certain Activities: The Consultant agrees that, during the term of this Contract and after its termination, the Consultant and any entity affiliated with the Consultant, as well as any Sub-Consultants and any entity affiliated with such Sub-Consultants, shall be disqualified from providing goods, works or services (other than consulting services) resulting from or directly related to the Consultant's Services for the preparation or implementation of the project.

**3.2.3 Prohibition of Conflicting Activities:** The Consultant shall not engage, and shall cause their Personnel as well as their Sub-Consultants and their Personnel not to engage, either directly or indirectly, in any business or professional activities that would conflict with the activities assigned to them under this Contract.

**3.3 Confidentiality:** Except with the prior written consent of the "Client/Employer", the Consultant and the Personnel shall not at any time communicate to any person or entity any confidential information acquired in the course of the Services, nor shall the Consultant and its Personnel make public the recommendations formulated in the course of, or as a result of, the Services.

**3.4 Insurance to be Taken out by the Consultant:** The Consultant (i) shall take out and maintain, and shall cause any Sub-Consultants to take out and maintain insurance, at their (or the Sub-Consultants', as the case may be) own cost but on terms and conditions approved by the "Client/Employer", insurance against the risks, and for the coverage specified in the SC, and (ii) at the "Client/Employer's request, shall provide evidence to the Client/Employer showing that such insurance has been taken out and maintained and that the current premiums therefore have been paid.

**3.5** Accounting, Inspection and Auditing: The Consultant (i) shall keep accurate and systematic accounts and records in respect of the Services hereunder, in accordance with internationally accepted accounting principles and in such form and detail as will clearly identify all relevant time changes and costs, and the bases thereof, and (ii) shall periodically permit the Client/Employer or its designated representative and/or the Client/Client/Employer, and up to five years from expiration or termination of this Contract, to inspect the same and make copies thereof as well as to have them audited by auditors appointed by the Client/Employer or the Client/Employer, if so required by the Client/Employer as the case may be.

**3.6 Consultant's Actions Requiring "Client/Employer's Prior Approval:** The Consultant shall obtain the "Client/Employer's prior approval in writing before taking any of the following actions:

(a) Any change or addition to the Personnel listed in Appendix C.

(b) Subcontracts: the Consultant may subcontract work relating to the Services to an extent and with such experts and entities as may be approved in advance by the Client/Employer. Notwithstanding such approval, the Consultant shall always retain full responsibility for the Services. In the event that any Sub-Consultants are found by the Client/Employer to be incompetent or incapable or undesirable in discharging assigned duties, the Client/Employer may request the Consultant to provide a replacement, with qualifications and experience acceptable to the Client/Employer, or to resume the performance of the Services itself. **3.7 Reporting Obligations:** The Consultant shall submit to the Client/Employer the reports and documents specified in Appendix B hereto, in the form, in the numbers and within the time periods set forth in the said Appendix. Final reports shall be delivered in CD ROM in addition to the hard copies specified in said Appendix.

3.8 **Documents Prepared** by the Consultant the Property the to be of "Client/Employer": All plans, drawings, specifications, designs, reports, other documents and software prepared by the Consultant for the Client/Employerunder this Contract shall become and remain the property of the Client/Employer, and the Consultant shall, not later than upon termination or expiration of this Contract, deliver all such documents to the Client/Employer, together with a detailed inventory thereof. The Consultant may retain a copy of such documents, but shall not use anywhere, without taking permission, in writing, from the Client/Employer and the Client/Employer reserves right to grant or deny any such request.. If license agreements are necessary or appropriate between the Consultant and third parties for purposes of development of any such computer programs, the Client/ Consultant shall obtain the Client/Employer's prior written approval to such agreements, and the Client/Employer shall be entitled at its discretion to require recovering the expenses related to the development of the program(s) concerned.

**3.9 Equipment, Vehicles and Materials Furnished by the "Client/Employer":** Equipment, vehicles and materials made available to the Consultant by the Client/Employer, or purchased by the Consultant wholly or partly with funds provided by the Client/Employer, shall be the property of the Client/Employer and shall be marked accordingly. Upon termination or expiration of this Contract, the Consultant shall make available to the Client/Employeran inventory of such equipment, vehicles and materials and shall dispose of such equipment and materials in accordance with the Client/Employer's instructions. While in possession of such equipment, vehicles and materials, the Consultant, unless otherwise instructed by the Client/Employer in writing, shall insure them at the expense of the Client/Employerin an amount equal to their full replacement value.

**3.10 Equipment and Materials provided by the Consultants:** Equipment or materials brought into the Government's country by the Consultant and the Personnel and used either for the Project or personal use shall remain the property of the Consultant or the Personnel concerned, as applicable.

**3.11 Office Accommodation:** The Consultant has to establish office in the proximity of the Shimla Smart City Limited for smooth functioning of the work.

# 4. CONSULTANTS' PERSONNEL AND SUB-CONSULTANTS

**4.1 General:** The Consultant shall employ and provide such qualified and experienced Personnel and Sub-Consultants as are required to carry out the Services with the approval of the Client.

**4.2 Description of Personnel:** (a) the title, agreed job description, minimum qualification and estimated period of engagement in the carrying out of the Services of each of the Consultant's Key Personnel are as per the consultant's proposal and are described in Appendix C. If any of the Key Personnel has already been approved by the Client/Employer, his/her name is listed as well.

(b) If required to comply with the provisions of Clause GC 3.1.1 hereof, adjustments with respect to the estimated periods of engagement of Key Personnel set forth in Appendix C may be made by the Consultant by written notice to the Client/Employer, provided (i) that such adjustments shall not alter the originally estimated period of engagement of any individual by more than 10% or one week, whichever is larger, and (ii) that the aggregate of such adjustments shall not cause payments under this Contract to exceed the ceilings set forth in Clause GC 6.1(b) of this Contract. Any other such adjustments shall only be made with the "Client/Employer's written approval.

(c) If additional work is required beyond the scope of the Services specified in Appendix A, the estimated periods of engagement of Key Personnel set forth in Appendix C may be increased by agreement in writing between the Client/Employer and the Consultant. In case where payments under this Contract exceed the ceilings set forth in Clause GC 6.1(b) of this Contract, this will be explicitly mentioned in the agreement.

**4.3 Approval of Personnel:** The Key Personnel and Sub-Consultants listed by title as well as by name in Appendix C are hereby approved by the Client/Employer. In respect of other Personnel which the Consultant proposes to use in the carrying out of the Services, the Consultant shall submit to the Client/Employer for review and approval a copy of their Curricula Vitae (CVs).

**4.4 Removal and/or Replacement of Personnel:** (a) except as the Client/Employer may otherwise agree, no changes shall be made in the Personnel. If, for any reason beyond the reasonable control of the Consultant, such as death, medical incapacity and separation from organization, it becomes necessary to replace any of the Personnel, the Consultant shall within seven days provide as a replacement a person of equivalent or better qualifications and experience.

(b) If the Client/Employer(i) finds that any of the Personnel has committed serious misconduct or has been charged with having committed a criminal action, or (ii) has reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Consultant shall, at the Client/Employer's written request specifying the grounds therefore, within seven days provide as a replacement a person with qualifications and experience acceptable to the Client/Employer.

(c) Any of the Personnel provided as a replacement under Clauses (a) and (b) above, as well as any reimbursable expenditures (including expenditures due to the number of eligible

dependents) the Consultants may wish to claim as a result of such replacement, shall be subject to the prior written approval by the Client/Employer. The rate of remuneration applicable to a replacement person will be the rate of remuneration paid to the replacement person. Also (i) the Consultant shall bear all additional travel and other costs arising out of or incidental to any removal and/or replacement, and (ii) the remuneration to be paid for any of the Personnel provided as a replacement shall not exceed the remuneration which would have been payable to the Personnel replaced.

(d) If the Consultant fails to provide replacement within stipulated time period under clauses (a) and (b) above, the consultant shall be liable to pay penalties as under which shall be deducted from the consultant invoice presented to the Client/Employer in each month:-

- i. Upto thirty days from the date of absence of the Personnel no penalty shall be imposed.
- ii.Between thirty days to sixty days from the date of absence 50% of the amount of salary of absentee Personnel shall be imposed.
- iii. Beyond sixty days from the date of absence 100% of the amount of salary of absentee Personnel shall be imposed till the replacement is provided by the consultant against the absentee Personnel.

### 5. OBLIGATIONS OF THE CLIENT CLIENT/EMPLOYER

**5.1** Assistance and Exemptions: Unless otherwise specified in the SC, the Client/Employer shall use its best efforts to ensure that the Government shall:

(a) Provide the Consultant, Sub-Consultants and Personnel with work permits and such other documents as shall be necessary to enable the Consultant, Sub-Consultants or Personnel to perform the Services.

(b) Arrange for the Foreign Personnel to be provided promptly with all necessary entry and exit visas, residence permits, exchange permits and any other documents required for their stay in India.

(c) Issue to officials, agents and representatives of the Government all such instructions as may be necessary or appropriate for the prompt and effective implementation of the Services.

(d) Provide to the Consultant, Sub-Consultants and Personnel any such other assistance as may be specified in the SC.

**5.2** Change in the Applicable Law Related to Taxes and Duties: If, after the date of this Contract, there is any change in the Applicable Laws of India with respect to taxes and duties, which are directly payable by the consultant for providing the services i.e. service tax or any such applicable tax from time to time, which increases or decreases the cost incurred by the Consultant in performing the Services, then the remuneration and reimbursable expenses otherwise payable to the Consultant under this Contract shall be increased or decreased

accordingly by agreement between the Parties hereto, and corresponding adjustments shall be made to the ceiling amounts specified in Clause GC 6.1(b).

**5.3** Services, Facilities and Property of the "Client/Employer": (a) The Client/Employer shall make available to the Consultant and its Personnel, for the purposes of the Services and free of any charge, the services, facilities and property described in Appendix E, at the times and in the manner specified in said Appendix E.

(b) In case that such services, facilities and property shall not be made available to the Consultant as and when specified in Appendix E, the Parties shall agree on any time extension that it may be appropriate to grant to the Consultant for the performance of the Services.

**5.4 Payment:** In consideration of the Services performed by the Consultant under this Contract, the Client/Employershall make to the Consultant such payments and in such manner as is provided by Clause GC 6 of this Contract.

**5.5 Counterpart Personnel:** If necessary, staff/professionals shall be made available to the Consultant for support in terms of liasoning with various line departments and other activities during the project development.

## 6. PAYMENTS TO THE CONSULTANT

**6.1** Total Cost of the Services (a) the total cost of the Services payable is set forth in Appendix D as per the consultant's proposal to the Client/Employer and as negotiated thereafter.

(b) Except as may be otherwise agreed under Clause GC 2.6 and subject to Clause GC 6.1(c), payments under this Contract shall not exceed the amount specified in Appendix-D.

(c) Notwithstanding Clause GC 6.1(b) hereof, if pursuant to any of the Clauses GC 4.2 (c) or 5.2 hereof, the Parties shall agree that additional payments shall be made to the Consultant in order to cover any necessary additional expenditures not envisaged in the cost estimates referred to in Clause GC 6.1(a) above, the ceiling or ceilings, as the case may be, set forth in Clause GC 6.1(b) above shall be increased by the amount or amounts, as the case may be, of any such additional payments.

**6.2** Currency of Payment: All payments shall be made in Indian Rupees. [In case the payment is to be made in the currency other that Indian Rupees, the same shall be mentioned instead of Indian Rupees]

6.3 Terms of Payment: The payments in respect of the Services shall be made as follows:

(a) The consultant shall submit the invoice for payment when the payment is due as per the agreed terms. The payment shall be released as per the work related milestones achieved and as per the specified percentage as per SC 13.

(b) Once a milestone is completed, the consultant shall submit the requisite deliverables as specified in this Contract. The Client/Employer shall release the requisite payment upon acceptance of the deliverables. However, if the Client/Employer fails to intimate acceptance of the deliverables or its objections thereto, within 30 days of receipt of it, the Client/Employer shall release the payment to the consultant without further delay.

(c) Final Payment : The final payment as specified in SC 13 shall be made only after the final report and a final statement, identified as such, shall have been submitted by the Consultant and approved as satisfactory by the Client/Employer. The Services shall be deemed completed and finally accepted by the Client/Employer and the final report and final statement shall be deemed approved by the Client/Employer as satisfactory ninety (90) calendar days after receipt of the final report and final statement by the Client/Employer unless the Client/Employer, within such ninety (90) day period, gives written notice to the Consultant specifying in detail deficiencies in the Services, the final report or final statement. The Consultant shall thereupon promptly make any necessary corrections, and thereafter the foregoing process shall be repeated. Any amount, which the Client/Employer has paid or caused to be paid in accordance with this Clause in excess of the amounts actually payable in accordance with the provisions of this Contract, shall be reimbursed by the Consultant to the Client/Employer within thirty (30) days after receipt by the Consultant of notice thereof. Any such claim by the Client/Employer for reimbursement must be made within twelve (12) calendar months after receipt by the Client/Employer of a final report and a final statement approved by the Client/Employer in accordance with the above.

(d) For the purpose of payment under Clause 6.3 (b) above, acceptance means; acceptance of the deliverables by the Client/Employer after submission by the consultant and the consultant has made presentation to the CMC / Client/Employer (Mention this if presentation is required) with / without modifications to be communicated in writing by the Client/Employer to the consultant.

(e) If the deliverables submitted by the consultant are not acceptable to the Client/Employer/ CMC, reasons for such non-acceptance should be recorded in writing; the Client/Employer shall not release the payment due to the consultant for the same. This is without prejudicing the Client/Employer's right to levy any liquidated damages under clause 9. In such case, the payment will be released to the consultant only after it re-submits the deliverable and which is accepted by the Client/Employer.

(f) All payments under this Contract shall be made to the accounts of the Consultant specified in the SC.

(g) With the exception of the final payment under (c) above, payments do not constitute acceptance of the Services nor relieve the Consultant of any obligations hereunder, unless the acceptance has been communicated by the Client/Employer to the consultant in writing and the consultant has made necessary changes as per the comments / suggestions of the Client/Employer communicated to the Consultant.

(h) In case of early termination of the contract, the payment shall be made to the consultant as mentioned here with: (i) Assessment should be made about work done from the previous milestone, for which the payment is made or to be made till the date of the termination. The consultant shall provide the details of persons reasonably worked during this period with supporting documents. Based on such details, the remuneration shall be calculated based on the man month rate as specified. (ii) A reasonable assessment of the reimbursable and miscellaneous expenses shall be made based on details furnished by the consultant in this regard with supporting documents and based on the assessment of the work done and the respective rates as provided. Wherever such an assessment is difficult, the rates should be arrived at by calculating the amount on pro-rata basis. The total amount payable shall be the amount calculated as per (i) and (ii) above plus any applicable tax.

### 7. FAIRNESS AND GOOD FAITH

7.1 Good Faith: The Parties undertake to act in good faith with respect to each other's rights under this Contract and to adopt all reasonable measures to ensure the realization of the objectives of this Contract.

**7.2 Operation of the Contract:** The Parties recognize that it is impractical in this Contract to provide for every contingency which may arise during the life of the Contract, and the Parties hereby agree that it is their intention that this Contract shall operate fairly as between them, and without detriment to the interest of either of them, and that, if during the term of this Contract either Party believes that this Contract is operating unfairly, the Parties will use their best efforts to agree on such action as may be necessary to remove the cause or causes of such unfairness, but no failure to agree on any action pursuant to this Clause shall give rise to a dispute subject to arbitration in accordance with Clause GC 8 hereof.

### 8. SETTLEMENT OF DISPUTES

**8.1 Amicable Settlement:** Performance of the contract is governed by the terms & conditions of the contract, in case of dispute arises between the parties regarding any matter under the contract, either Party of the contract may send a written Notice of Dispute to the other party. The Party receiving the Notice of Dispute will consider the Notice and respond to it in writing within 30 days after receipt. If that party fails to respond within 30 days, or the dispute cannot be amicably

settled within 60 days following the response of that party, clause GC 8.2 shall become applicable.

**8.2** Arbitration: In the case of dispute arising upon or in relation to or in connection with the contract between the Client/Employer and the Consultant, which has not been settled amicably, any party can refer the dispute for Arbitration under (Indian) Arbitration and Conciliation Act, 1996. Such disputes shall be referred to an Arbitral Tribunal consisting of 3 (three) arbitrators, one each to be appointed by the Client/Employer and the Consultant, the third arbitrator shall be chosen by the two arbitrators so appointed by the parties and shall act as Presiding Arbitrator. In case of failure of the two arbitrators, appointed by the parties to reach a consensus regarding the appointment of the third arbitrator within a period of 30 days from the date of appointment of the two arbitrators shall be appointed by the Secretary of Urban Development Department, Himachal Pradesh. The Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof, shall apply to these arbitration proceedings.

8.3. Arbitration proceedings shall be held in Shimla and the language of the arbitration proceedings and that of all documents and communications between the parties shall be English.

8.4 The decision of the majority of arbitrators shall be final and binding upon both parties. The expenses of the arbitrators as determined by the arbitrators shall be shared equally by the Client/Employer and the Consultant. However, the expenses incurred by each party in connection with the preparation, presentation shall be borne by the party itself. All arbitration awards shall be in writing and shall state the reasons for the award.

### 9. Liquidated Damages

9.1 The parties hereby agree that due to negligence of act of any party, if the other party suffers losses, damages the quantification of which may be difficult, and hence the amount specified hereunder shall be construed as reasonable estimate of the damages and both the parties agree to pay such liquidated damages, as defined hereunder as per the provisions of this Contract.

9.2 The amount of liquidated damages under this Contract shall not exceed **10** % of the total value of the contract as specified in Appendix D.

9.3 The liquidated damages shall be applicable under following circumstances:

(a) If the deliverables are not submitted as per the work plan agreed under this agreement, the Consultant shall be liable to pay 1% of the cost of the services delayed of each week or part thereof and subject to clause 9.2.

(b) If the deliverables are not acceptable to the Client/Employer as mentioned in Clause 6.3 (f), and defects are not rectified to the satisfaction of the Client/Employer within 30 days of the

receipt of the notice, the Consultant shall be liable for Liquidated Damages for an amount equal to **1**% of total cost of the services for every week or part thereof for the delay.

### 10. Miscellaneous provisions:

(i) "Nothing contained in this Contract shall be construed as establishing or creating between the Parties, a relationship of master and servant or principal and agent.

(ii) Any failure or delay on the part of any Party to exercise right or power under this Contract shall not operate as waiver thereof.

(iii) The Consultant shall notify the Client/Employer of any material change in their status, in particular, where such change would impact on performance of obligations under this Contract.

(iv) Each constituent of the Consultant, in case of a consortium, shall be jointly and severally liable to and responsible for all obligations towards the Client/Employer for performance of works/services including that of its Associates/Sub Contractors under the Contract.

(v) The Consultant shall at all times indemnify and keep indemnified the Client/Employer against all claims/damages etc. for any infringement of any Intellectual Property Rights (IPR) while providing its services under the Project.

(vi) The Consultant shall at all times indemnify and keep indemnified the Client/Employer against any claims in respect of any damages or compensation payable in consequences of any accident or injury sustained or suffered by its (the Consultant's) employees or agents or by any other third Party resulting from or by any action, omission or operation conducted by or on behalf of the Consultant.

(vii) The Consultant shall at all times indemnify and keep indemnified the Client/Employer against any and all claims by Employees, Workman, Contractors, sub-contractors, suppliers, agent(s), employed engaged or otherwise working for the Consultant, in respect of wages, salaries, remuneration, compensation or the like.

(viii) All claims regarding indemnity shall survive the termination or expiry of the Contract.

(ix) It is acknowledged and agreed by all Parties that there is no representation of any type, implied or otherwise, of any absorption, regularization, continued engagement or concession or preference for employment of persons engaged by the Consultant for any engagement, service or employment in any capacity in any office or establishment of the Government of India/ State or the Client/Employer.

### **11. Performance Security**

The Performance Security shall be provided to the Client/Employer not later than the date specified in the Contract and shall be issued in an amount specified in the SCC, through bank

acceptable to the Client/Employer, and denominated in the types and proportions of the currencies in which the total cost of services is payable. The Performance Security shall be valid until a date 28 days from the date of issue of the Certificate of Completion in the case of a bank guarantee.

**12. Jurisdiction:-** All disputes concerning this agreement shall be put to adjudication only in Shimla Courts.
