- 8. Scanned copy of Registration Certificate related to Goods & Service Tax, PAN card and Letter of Registration as Contractor, shall be uploaded by the tenderer, otherwise the bid is likely to be rejected.
- 9. The work shall have to be completed in time, failing which penalty for non-completion of work in time shall be imposed, as stated in the Bid Document. Please note that there is a provision of Bonus for early completion of work.
- 10. Bidders who have rescind work in any department / PSU shall not be eligible to participate in the bidding process.
- 11. Bidders shall provide their Banker's contact details, so that JUIDCO Ltd can contact the Bank, if required.
- 12. If any work is awarded to a bidder after submission of bid to JUIDCO Ltd, his bid capacity shall be reduced by that bid amount as indicated in Para 1.4 of Qualification Information (Section-3).
