### Qualification Bid Information

## 1.0 **Instruction to the Applicant Bidders:**

- 1.1 Qualification Bid is open to contracting firms registered in appropriate "Class" (AA or equivalent) with necessary experience of similar type of works, solvency & turnover as given in Qualification Criteria. The qualification of contractors and their eligibility limit for award of contract will be determined on the basis of evaluation of information furnished in bid with qualification criteria i.e. their past experience, technical qualifications and financial capabilities. Applicants are required to submit general information about their firm/company in Annx-1-A and their experience, registration & solvency in Annx-1-B.
- 1.2 Instructions to Tenderers and General conditions of contract are described in detail in Volume-I of tender for this work. General information on the project details, access to site, technical details, datasheet, specifications, scope of work, Special conditions of contract are given in Volume-II of tender for this work. Instructions & guidelines to tenderers for quoting the lump sum price for the work are given in Volume-III of tender for this work. Tenderers are advised to go through all the data & details given in all the volumes of tender.
- 1.3 The tenders will be opened online in presence of bidders and opening authority. The tenders will be evaluated in two stages i.e. qualification Bid &Technical Bid in first stage and Price Bid for qualified bidder in second stage.
- Hard copy cover containing EMD & Tender Fees will be opened by competent authority of, 1.4 Surat Municipal Corporation on next working day after last date of receipt of the EMD & Tender fee, if possible at 4.30 P.M. Tenderer's authorized representatives may remain present at the time of opening of the EMD & Tender Fees of tender. Online submitted Price Bid shall not be opened until scrutiny of qualification and technical bid is completed by Surat Municipal Corporation. Initially scrutiny of all the records of experience, registration, turnover & solvency etc. as submitted by the tenderer online pertaining to qualification criteria mentioned in tender shall be carried out by Surat Municipal Corporation. Technical bid data submitted online of only those bidders whose experience, registration, solvency & turnover etc. at least match with or are superior to the qualification criteria mentioned in tender will be considered for evaluation. Online submitted Price Bid shall not be opened until scrutiny of Technical bid of bidders meeting qualification criteria mentioned in tender is completed by Surat Municipal Corporation. Only successful bidder whose technical bids are qualified will be informed accordingly. After scrutiny of technical-bid, Online submitted Price-Bid (Volume-III) of only those tenderers will be opened whose tenders & E.M.D. are found fulfilling the requirement of the tender terms & conditions, who meet qualification criteria mentioned in tender and whose technical bid is evaluated and qualified on a date convenient to Surat Municipal Corporation. Tenderers authorized representatives may remain present at the time of opening of the Price-Bid of tender. Conditional tenders are liable to be rejected. Tender without required E.M.D. & Tender Fees will be summarily rejected without assigning any reasons thereof.
- 1.5 The direct or indirect mention regarding price of the proposed project in Qualification Bid or its enclosures shall be liable for outright rejection of tender.

# 1.6 Joint venture for the proposed work will not be permitted. Experience of joint venture / consortium / back to back will not be considered for qualification evaluation.

### 2.0 **Qualification Criteria**

Qualification for this work will be based on Applicants meeting **the entire** following minimum criteria regarding their particular experience, financial position, personnel and equipment capabilities and other relevant information as demonstrated by the Applicant's responses in the forms attached. The qualifications, capacity and resources of proposed sub

contractors will not be taken into account in determining the applicant's compliance with the qualifying criteria.

## (A) Qualification Criteria:

- 1) Registration in unlimited class with central or any State of india of PWDs / CPWD / MES / surat Municipal Corporation Class-AA or equivalent will be consider.
- (I) At least 3 similar\* completed works of capacity not less than 58.00 MLD (II) At least 2 similar\* completed works of capacity not less than 72.00 MLD (III) At least 1 similar\* completed works of capacity not less than 115.00 MLD in last 7 years with cut-off <u>date</u> <u>ending on 31-03-2016</u> (i.e. Experience of duration from 01-04-2009 to 31-03-2016 will only be considered.) The bidder shall state all the completed works as per these criteria in <u>Annx-2-A</u>. All the certificate to be submitted duly signed by respective authority not below the rank of executive engineer or equivalent.
- Average Annual Turnover in last 3 years ending 31st March, 2016 should be at least **Rs.1638.30 Lac or more**.

The tenderer shall submit 'Digitally Signed' of solvency certificate of nationalize or schedule bank (IDBI Bank, AXIS Bank, HDFC Bank, ICICI Bank, Yes Bank ltd. And The surat peoples co-op bank ltd.) Amounting at least about upto 20% (minimum amount of Rs. 1092..20 Lac) of the estimated amount. The Validity of Solvency certificate shall be six months from the date of opening of the Technical Bid of tender.

• Similar work means

\* Design, Construction, Procurement, Testing and Commissioning of lamella clarifier based Water Treatment Plant works successfully completed on EPC basis in India during last 7 years including civil, piping, mechanical, electrical and instrumentation work based on PLC-SCADA system etc. including zero liquid discharge facility will be considered as experience of similar type of work.

If bidder do not have executed ZLD facility in WTP then bidder must have the experience of Sludge thickening as well as mechanical sludge dewatering facility experience in the sewage treatment plant to meet the above requirement.

Minimum 2 years of experience of O & M of at least one 120 MLD WTP of any technology with PLC-SCADA system in India is required to be qualified.

All tenders shall be evaluated considering the enlisted multiplying factors. Following enhancement factors will be used for the cost of works executed and financial figures to arrive at common base for the value of the works completed in India. **Cut of month shall be considered as a month of tender submission.**

Bidder should indicate actual figures of costs and amount for the work executed without accounting for the above-mentioned factors.

- (B) Successful Tenderer shall submit original down loaded copy of tender for the work mentioned in this tender duly stamped and signed.
- (C) The tenderer shall furnish all details as asked in this and various other sections of this tender document with all necessary supporting documents.
- (D) The tenderer shall submit 'attested copy' of their relevant registration certificate with the SURAT MUNICIPAL CORPORATION, Surat or State Government in India or Government of India or Railways/ Military Engineering Services.
- (E) The tenderer shall submit 'attested copy' of valid solvency certificate, as issued to them by their bank.
- (F) The tenderer shall submit 'attested copy' of details of his turnover for the last five financial years (2011-12 to 2015-16), as certified by his Chartered Accountant.
- (G) The tenderer shall submit 'attested copy' of relevant experience certificates of works as stated in (A) above.
- (H) The tenderer shall submit 'attested copy' of partnership deed in case of a partnership firm.

1) (i)The contractor shall have to furnish affidavit as per attached format on no-judicial stamp paper of Rs.100/- duly notarized. This affidavit shall be submitted in hard copy along with EMD & Tender fees. This affidavit mentioned on page no.17, Annexure-VI of Qualification Bid and mentioned elsewhere in the tender documents.

(ii) E.M.D. & Tender fee shall be submitted in electronic format only through online (by scanning) while uploading the bid. This submission shall mean that E.M.D. & tender fee are received for purpose of opening the bid. Accordingly offer/tenders of those tenderes whose E.M.D. & tender fee is received electronically shall be opened. However for the purpose of realization of EMD & Tender fee, bidder shall send the EMD as well as tender fee in required format in original through RPAD/Speed post so as to reach to Account Department (Main Office) within 7 days from the last date of submission of price bid. Penal action shall be initiated for non submission of EMD and Tender fees in original to Account Department (Main Office) by bidder, including abeyance of registration and cancellation of E-tendering code for One year. All documents in supporting of bid shall be in electronic format only through online (by scanning) during the bidding period & hard copy will not be accepted separately."

• All documents must be coloured scanned to be seen as a original. Scanning in black and white or gray shall not be acceptable.

- All the documents must be notarized with clearly displaying stamp, number and name of the notary.
- "Following Documents shall only be submitted in HARD COPY to Surat Municipal Corporation by all bidders."

- Tender Fees as mentioned in the tender.

The applicants to note specifically that, all information to be given by them including those in the form of various formats, must be supported by certificates, duly attested, without which these will not be considered for their qualification.

## Bidders shall also state the details of similar type of ongoing works in <u>Annx-2-B</u>. However, ongoing works shall not be considered for their qualification.

#### 3.0 **Personnel Capabilities**

The applicant shall supply general information on the management structure of the firm in **Annx-3-A** and shall make provision for qualified personnel to fill the key positions as required during contract implementation. The applicant is required to give details of proposed site organization & technical/key personnel to be employed for the proposed project in **Annx- 3-B**.

#### 4.0 Equipment Capabilities

All the concreting work for the proposed water treatment plant shall be carried out by automatic digital type weigh-batching plant & concrete mixer (minimum 7.5 m3 capacity) to be installed at the site for the proposed work. Volumetric batching of concrete ingredients shall not be allowed in any case. The applicant is required to own or have assured access through hire or lease to the key items of equipment required for implementation of the project. The applicant shall give details of equipment, plants and machinery, testing facility available with him in **Annx-4-A** and to be engaged during the implementation of the proposed project in **Annx-4-B**.

#### 5.0 **Litigation History**

The Applicant should provide accurate information about any litigation or arbitration resulting from contracts completed or ongoing under its execution over the last five years. A consistent history of awards against the applicant will result in disqualification of the applicant. (Annx-5-A & 5-B)

#### 6.0 **Disqualification**

Even though the Applicants meet the above criteria, they are subject to be disqualified to apply for any bidding process by Surat Municipal Corporation for a period of 5 years if applicant has:

- Made misleading or false representation in the forms, statements and attachments submitted; or

The applicants are also subject to be disqualified if applicant has;

- Records of poor performance during the **last 5 years**, as on the date of application such as abandoning the work, rescinding of contract for which the reasons are attributable to the non-performance of the contractor, inordinate delays in completion, consistent history of litigation awarded against the applicant or any of its constituents or financial failure due to bankruptcy, etc.
- Being debarred by R & B / PW Dept. or any State/ central Government department as on the date of application.
