- 2. The Cable Suspension bridge for Non-Motorised Transport shall be constructed at Bhatauli.

3. The Scope of Work consists of:

- a) To carry out detailed design for Cable Suspension bridge for Non-Motorised Transport(Pedestrians only)(12meter wide and length of 300 m approx. - single span)with earth fill ramps for approaches (if required as per site) at Bhatauli.
- b) The bridge shall be a cable suspension bridge.
- c) The bridge is to be constructed over a depression having about 5 to 7 meters constant depth and length is about 250 to 300 meters. The bidder is advised to visit the site.
- 4. The project will be implemented on Turnkey basis i.e., Contractors will design, construct and also maintain for period of 5 years after completion of work. The time period for completion of the project shall be 24 months from the award of the project.
- 5. The successful bidder would be required to carry out the following activities or as mentioned in the RFP but not limited to these,
 - i. Site investigation including topographical and sub-soil investigation.
 - ii. Prepare detailed design and drawings for the bridge and approaches (if required) duly proof checked by IITs, NITs or Engineers India Limited (EIL).
 - iii. The complete design and drawings which has been proof checked shall be submitted for approval from the Employer before taking up the execution.
 - iv. Carry out construction of the bridge as per approved drawings.
 - v. Maintain the bridge and its approaches for a period of 5 years after its completion.
 - vi. The employer *(JSCL)* will engage an Engineer to supervise and approve the works during the period of execution.

Qualification Criteria for Bidders:

- a) The Applicant or its Partner/Associate in case of JV/ Association firms must have designed and executed a *(cable suspension bridge or a cable stayed bridge)* bridgeproject having main span of minimum 300 meters during the last 10 years. The bidders must submit detailed particulars and GADS (i.e., name of Client, location of the bridge, year of award and completion, value of project, details of span arrangement, type of bridge etc.) of such bridges executed by them.
- b) The applicant can be a single firm or voluntarily formed joint venture meeting the eligibility criteria as above.
- c) The work is proposed to be taken up for construction by June, 2017. The Applicant has to submit the general information about the individual firm/each partner of Joint Venture in the prescribed formats (Annexure I, II and III available) along with the Expression of Interest.
- d) The Expression of Interest must be delivered at the following address on or before 1730 hours local time on 25.03.2017. Applications received after the prescribed date will not be considered for shortlisting.
